Indicative Module Content

The module presents a a series of themes in relation to the evolution and critique of the Modern Movement in Architecture post WWII, through the introduction of key texts and projects of the period. An important aspect of the course is the relationship between the various theories put forward, and their expression or implementation in particular forms, projects and compositional traits.

Module Delivery

Lectures in the architectural history, theory & social context of Modernism introduce the broader picture. These are supplemented by tutorials, seminars and other forms of blended learning including online activities intended to develop deeper understanding and self?directed learning.
