Aims of Module

To enable students to obtain a knowledge and understanding of the legal status of the main types of commercial contract and how they operate.

- 1 Consider the main forms of commercial transaction and relationships.
- 2 Critically evaluate the legal content of and requirements surrounding the key commercial contracts and relationships.
- 3 Apply the knowledge and understanding of key commercial contracts and relationships to practical situations.

Indicative Module Content

Comparison of business vehicles such as sole trader, partnership and company; agency; sale and carriage of goods; insurance; intellectual property; cautionary obligations; negotiable instruments; money and banking; debt recovery and diligence; bankruptcy; the influence of the EU on national commercial law.

Module Delivery

This is a lecture and tutorial based module. Lectures provide core module content. Tutorials develop associated higher level skills through student centred learning. In the distance learning mode, in addition, online activities will form part of the module contact time.

Explanatory Text
