Aims of Module

1. To provide students with a working understanding of practical legal skills and knowledge such as of dispute resolution, written and oral advocacy, negotiation and client interviewing and counselling. 2. To enable students to obtain knowledge and understanding of the idea of justice, the idea of unjust law and the moral and ethical basis and context of law. 3. To allow students to understand the principles of ethical legal practice, and standards of professional conduct for lawyers in Scotland.

Learning Outcomes for Module

On completion of this module, students are expected to be able to:

- 1 Develop and demonstrate key document drafting skills pertinent to legal practice.
- 2 Explain and demonstrate a critical understanding of the nature of legal concepts including legal rights, legal obligation and legal powers.
- Explain and demonstrate a critical understanding of the idea of justice, the idea of unjust law, the moral and ethical basis and context of law and of ethical legal practice, and standards of professional conduct for lawyers in Scotland.
- Demonstrate a practical knowledge and understanding of sound client interviewing and negotiating techniques.
- 5 Appraise the range of dispute resolution methods available.

Indicative Module Content

One part of the module will develop key practical transferrable skills required in the workplace such as knowledge of dispute resolution alternatives, written drafting skills, client interviewing and counselling and negotiation skills. The other part of the module will cover knowledge and understanding of major legal concepts including legal rights, obligation and powers and the idea of justice and of unjust law, the ethical basis of law and of legal practice and professional conduct for lawyers.
