To develop knowledge of Entrepreneurship and Small Business theory in relation to the legal sector and an understanding of how enterprise skills can be used to generate new income streams.

Indicative Module Content

Enterprise-based strategies in relation to the traditional model of legal business practice will be covered. The content is directed towards developing new business models for use in the legal sector.
