To provide students with a broad understanding of information literacy as it relates to the contemporary library, information and knowledge work environment, and enable them to identify ways in which the information professional can support others in becoming information literate.

Indicative Module Content

The module introduces current information literacy concepts, models and processes; includes the changing characteristics and nature of information; introduces the concepts of information seeking behaviour, identifying information needs, finding and evaluating information using a range of sources; organising, using and communicating information to achieve personal, social, occupational and educational goals; supporting others to become information literate; information literacy as a core prerequisite of the information society and as a key component of lifelong learning.

Module Delivery

The module is delivered through a combination of online topics, individual and groupwork activities, discussion, directed reading and individual investigation.
