Aims of Module

- 2 Formulate a research proposal and translate this into a feasible plan for its execution and completion within the timescale available.
- 3 Critically evaluate a range of appropriate research methods, and use the selected one(s) in a competent and professional manner.
- 4 Analyse and critically evaluate the results obtained from research.
- ⁵ Produce a 7000 word dissertation or report on the topic written to professional standards and, if required, orally present and defend the same.

Indicative Module Content

This will be specific to each individual dissertation/ report. Normally will involve: research proposal; research methods; literature review; critical analysis and evaluation of research material; findings/recommendations.

Module Delivery

The dissertation/ report is prepared under the direction of an academic supervisor.
