# **Explanatory Text**

The module is assessed by the host study abroad institution. # **ADDITIONAL NOTES**

Students will join cohorts in partner institutions which are at SCQF Level 8 or equivalent. This module will normally be delivered in English. Students wishing to undertake the module in the host language will only be allowed to do so if certified to do so at the appropriate level.

Modules (sometimes called courses at partner institutions) may differ in credit size (hours) from the standard 7.5 ECTS at RGU, therefore students will be expected to achieve 30 ECTS per semester by successfully achieving the relevent number of modules at the host institution (this could be more or less than the standard 4 at RGU).

ECTS (or other local) credits awarded by the host institution will be shown on the transcripts provided by them. 30 ECTS (or local equivalent) will then be translated into the successful achievement of 4 Study Abroad modules at RGU.
