Practice Placement: Informed consent, communication skills, methods and styles, accurate record and document keeping, data protection, confidentiality, risk management/ H&S legislation, moving and handling, fire regulations, human factors, adult and child protection, infection control policies and procedures, recognising and managing violence and aggression in the workplace, awareness of the patient, adult basic life support, equity, diversity and ethnicity, awareness of safe use of walking aids, aids to daily living and wheelchairs, food safety/ hygiene.
