Management of complaints. Personal development, continuing professional development, reflection. Application and modification of higher level techniques in the core areas of physiotherapy practice - AD, Functional Capacity Evaluation, Manual Therapy, Electrical Stimulation. Work fitness and ergonomics. Legal responsibilities and ethical considerations of professional practice. Awareness of local and national guidelines, standards and policies related to patient care.
