Application and modification of current evidence-based higher-level techniques in the core areas of physiotherapy practice; respiratory; neurological; MSK. Simulated practice. Interprofessional working. Legal responsibilities and ethical considerations of professional practice. Equality and diversity policy. Awareness of local and national guidelines, standards and policies related to clinical practice and patient care.
