#### Aims of Module

To introduce students to the study of law by providing them with the ability to use legal research skills, an understanding of the sources of the law and the ability to interpret and use these sources, and introduce them to the core professional legal writing and presentation skills. To introduce students to the contextual, moral and ethical basis of law and legal practice and standards of professional conduct for lawyers in Scotland.

- Make effective use of a law library; identify, retrieve and use information from a range of access points and demonstrate basic numeracy skills in making use of legal research statistics

- Demonstrate understanding of the moral and ethical basis of law and legal practice and standards of professional conduct for lawyers in Scotland.

Distinctive features of legal literature; sources of the law; legal research skills and information retrieval techniques; use of legal research statistics reading and analytical skills appropriate for primary legal sources; legal writing, problem solving and reasoning, statutory interpretation, legal ethics
