- 2 Critically evaluate the legal requirements, from a holistic perspective, for the operations of charities and other juristic bodies of the UK third sector.
- 3 Demonstrate and evaluate the legal underpinning and understanding of the essential values that are pivotal for the sustenance of charities as well as other juristic bodies of the UK third sector.
- 4 Critically demonstrate the understanding of a UK charity's regulatory and governance requirements; applying same to practical situations regarding working in or with anybody, natural or juristic within the UK third sector.

Introduction to UK Charity Law and the Third Sector; Public Benefit, Charity Governance & Legal Structures; Data Protection; Charity Finance; The Regulators, Employment and Volunteering; Vulnerable Persons; Trading; Trust & Equity, Transparency & Integrity; Risk Exposure & Management; Professional Practice and Ethics of the Charity Lawyer; Dispute Resolution.
