Aims of Module

To undertake comparative study of several contemporary issues in modern Company Law; to facilitate deep understanding of and to develop analytical skills in the area of comparative Company Law; and to analyse the development of company and corporate law with particular reference to the jurisdictions of the EU.

Learning Outcomes for Module

On completion of this module, students are expected to be able to:

- Demonstrate an in depth knowledge of major company law problems and how they are addressed in different jurisdictions throughout the EU and the United States of America.
- 2 Advise on International Company Law Issues.
- 3 Undertake comparative analysis of Company Law.

Indicative Module Content

The module will revolve around some important developmental 'themes' of company law. Examples, case studies and module contact will be drawn from various jurisdictions around the world but with particular reference to jurisdictions of the EU. The most commonly referred to laws will be those of the UK, USA and the European Union. Topics studied will include: the nature, formation and constitution of companies; the multinational; corporate governance; regulations of Companies; corporate failure; acquisitions and Mergers; insider dealing; regulation of private equity; corporate crime; cross jurisdictional taxation of companies; elements of international regulation.

Module Delivery

This is a lecture and seminar based module. Lectures provide core module content. Seminars develop associated higher level skills through student centred learning.
