Aims of Module

To enable the students to understand the basic concepts and relevance of international private law norms and to critically analyse the concepts of jurisdiction and connecting factors and areas of substantive Scots international private law.

Learning Outcomes for Module

On completion of this module, students are expected to be able to:

- 1 Explain the concept and apply the content of the main areas of Scots international private law.
 - Analyse different approaches taken by various international conventions and foreign jurisdictions to the use
- 2 of certain connecting factors in the key areas of jurisdiction, choice of law and recognition and enforcement of judgements.
- 3 Critically evaluate the Key substantive legal subjects of Scots international private law.

Indicative Module Content

The concept of international private law and its purpose; the key concepts of jurisdiction, choice of law and recognition enforcement of judgements; examination of the main connecting factors used in international private law including domicile, nationality and habitual residence. examination of the use of these concepts in international conventions and European Regulations; substantive aspects of Scots international private law such as contact, delict, marriage, civil parentship, divorce, parent and child, property and succession.

Module Delivery

This is a lecture and seminar based module. Lectures provide core module content. Seminars develop associated higher level skills through student centred learning.
