The 34 NMC generic and 9 field specific standards for competency for entry to the professional register. These sit within the domains of Professional values, Communication and interpersonal skills, Nursing practice and decision-making and Leadership, management and team working. The NMC defined essential skills which sit within 5 clusters; Care compassion and communication, Organisational aspects of care, Infection prevention and control, Nutrition and fluid management, Medicines management. The NMC defined essential skills which includes the administration of medicines and a range of numerical skills to be demonstrated in practice. Community nursing and public health nursing.
