#### Aims of Module

To develop the knowledge, skills and professional behaviours required of a pharmacist in the practice setting.

## **Learning Outcomes for Module**

On completion of this module, students are expected to be able to:

- Demonstrate knowledge and understanding of the legal, professional and ethical requirements that underpin professional practice of a pharmacist in the supply of medicines, appliances and services.
- 2 Demonstrate appropriate knowledge, skills and professional behaviours required of a pharmacist.
- 3 Effectively communicate with patients, the public and the wider healthcare team.
- 4 Reflect on personal and professional aspects of pharmacy practice.

#### **Indicative Module Content**

Development of aspects of pharmacy practice relating to the patient, the medicine and the profession, with an emphasis on the safe and legal supply of medicines and development of knowledge, skills and professional behaviours required by a pharmacist. Topics include: developing professional responsibilities required of a pharmacist, including ethical responsibilities; current legislation affecting pharmacy practice; supply of medicines and legal frameworks; public health; pharmaceutical calculations; communication and consultation skills; reflective practice; equity, diversity and inclusion; sustainability. Integration of the structure, function, physiological processes and regulatory mechanisms of the human body with drug absorption, distribution, metabolism and excretion through consideration of the following body systems: cardiovascular, gastrointestinal, integumentary, respiratory and renal systems. The module highlights the need for ensuring health and well-being (SGD 3 good health and well-being) and reducing inequalities (SDG 10: reduced inequalities) while making conscious decisions about the use and disposal of resources required to provide a quality learning experience with minimal environmental impact (SDG 4: quality education and SGD 12: responsible consumption and production).
