The specific child centred components of the module reflect the knowledge requirements within the Key Capabilities in Child Care and Protection (Scottish Executive, 2006).

Module Delivery

The primary mode of delivery will be lectures with the seminars acting as a forum for the development of higher cognitive skills through discussion of problems and case studies. In addition, students will be directed to study relevant literature.
