Aims of Module

To provide the student with the ability to understand and apply a range of communication, assessment and intervention skills relevant for social work practice.

- 2 Apply social work intervention within the context of evidence based practice.
- 3 Evidence practice skills in readiness for practice.
- 4 Reflect on practice skills and identify areas for development.

Indicative Module Content

Symbolic, verbal and non-verbal communication. Use of questions, probing, empathic reflection. Non directive and structured approaches to interviewing. Interviewing skills with individuals and families. Methods of assessment and risk assessment. Methods of social work intervention including: direct work with children, life space skills, task centred case work, care management, psycho-social case work. Cognitive behavioural social work, and models of family therapy. Evidence based practice. Reflective practitioner skills. Reflects the knowledge, skills and professional confidence and competence requirements around engagement with public protection.

Module Delivery

Extensive use will be made of seminars for discussion, application, simulation and skills rehearsal. Core information will be provided by lectures and student centred learning.
