Aims of Module

To enable students to develop a critical understanding of the short and longer term impact of adversity on development and functioning. To enable students to understand and apply appropriate therapeutic models of working to facilitate recovery and develop resilience.

Therapeutic approaches and development of skills for working with groups and individuals to develop resilience. The pedagogy of relationships. Safe care. Evidence based practice. Assessment, planning and review. Values. Codes of practice.
