- 3 Write up a dissertation which critically evaluates their research findings and their implications for practice

Indicative Module Content

Advanced web/literature searching, time management, recording, data handling. Dissertation writing skills; presentation skills, structuring, drafting/editing. Research in Practice; informing and evaluating social work practice. Critical writing. Where the student chooses a child centred topic for their Dissertation they will draw from knowledge and research of the subject matter and meet the expectations and knowledge requirement of Key Capabilities in Child Care and Protection (Scottish Executive, 2006).

Module Delivery

Workshops. Each student will be allocated a dissertation supervisor from whom he/she will receive tutorial support and advice. The meetings will be initiated by the student and the supervisor will act as facilitator. ODL and web-based material
