## **Indicative Module Content**

Communication skills including oral, non-verbal and in writing. The ability to gather, collate and analyse information from various sources. Assessments and risk assessments, action plans. Methods of intervention, psycho-social, crisis intervention, opportunity led and life space approaches and behavioural social work. An awareness at all times of the potential for risk to children. The nature and relevance of research. Sources of research and advanced literature searching. A review of the major methods relevant to social science and social work research. Interpreting statistics and data analysis. Application of research in social work practice. Evaluation skills and research. Ethical theories, issues and dilemmas. Traditional and modern values in social work. Professional codes of ethics and other sources of social work values. Ethical principles and their application in professional practice. Ethical issues relating to: respect; privacy and confidentiality; informed consent; self determination and empowerment. Anti-oppressive practice, the promotion of social justice and the moral rights of service users. The content also reflects, where appropriate, the knowledge, skills and professional confidence and competence requirements of the Key Capabilities in Child Care and Protection (Scottish Executive 2006).
