#### **Aims of Module**

To enable the student to demonstrate learning accrued in a simulated professional environment. To use academic knowledge to underpin and broaden professional skills.

Component 1 - The assessment is conducted by means of appraisal by the academic mentor following the approved University assessment scheme for this element. The scheme for assessment is designated to assess Learning Outcomes 1-4 and consists of each student providing a portfolio of evidence which will contain the following:

- a) a learning contract
- b) documentation from the periodic reviews
- c) evidence from the student's Personal Development Planner to support the learning achieved
- d)reflective diary
- e)further evidence deemed appropriate by the student to demonstrate that the Learning Outcomes set have been achieved.

On completion of the module students will be required to attend a portfolio review with the University mentor.
