Indicative Module Content

This module will cover: the basic need for shelter and the creation of habitation, communities and purpose of space based on belief and ritual. The evolution of art, design and decoration and the idea of personal space. The classical temple, the cella, and the processional route as a place of ceremony and worship. The Roman basilica, amphitheatre and thermae as architecture of the public realm. The relationship between liturgy, spatial composition and structural form in Abrahamic religions. The development from fortified settlement to the merchant classes of the renaissance and the palazzo. The baroque era of the monarchical palace and basilica and the use of decoration and ornament in applied and decorative arts. The application of technological and structural advancements to deliver optimum spatial environments and the rise of the middle and working classes and the concept of the home. To conclude with the removal of ornament and principles of functionality in design and utility. Please note that attention should be paid to considering opportunities within design practice where appropriate actions can be taken to heighten the potential for positive sustainable impact. Whilst there may be links to the full suite of SDGs, within the context of this module, it would be expected that appropriate consideration is paid to SDGs 9, 11 and 12 as a baseline.
