#### **Aims of Module**

The module aims to provide students with the opportunity to gain academic credit through learning applied in a variety of settings. The module will enable students to identify their learning needs and negotiate learning to develop skills or strategies that aim to push boundaries and pioneer change in the workplace, placement, or independent learning setting.

# **Module Delivery**

The module is delivered in Blended Learning mode using structured online learning materials/activities and directed study, facilitated by regular online tutor or mentor support. The module will primarily be student-led delivery with support from appropriate staff. Students will negotiate their topic and develop a learning plan for completion of the module.
