## Aims of Module

To enable the students to develop independence in meeting Nursing and Midwifery Council (NMC) standards of proficiency by demonstrating safe, family-centred midwifery care through guided participation.

- 2 Midwifery Practice Assessment Documentation (MPAD), to meet progression criteria for entry to Part 3 of the programme.
- <sup>3</sup> Apply a strengths-based approach, which empowers mothers and families by recognising and respecting their choices when developing plans of care.
- 4 Collaborate with the multi-disciplinary team using effective communication to address complex needs.
- 5 Explain appropriate referral to specialist and third sector services.

#### **Indicative Module Content**

Preparation for practice; The NMC proficiencies for part 2 which are grouped under six domains: (1) Being an accountable, autonomous, professional midwife; (2) Safe and effective midwifery care: promoting and providing continuity of care and carer; (3) Universal care for all women and newborn infants;(4) Additional care for women and newborn infants with complications;(5) Promoting excellence:the midwife as colleague, scholar and leader; (6) The midwife as skilled practitioner.

Practice learning experiences in a variety of health and social care environments that meet the NMC standards for student supervision and assessment (SSSA; 2018) and Quality Standards for Practice Learning (QSPL; NES 2020).

# **Explanatory Text**

Practice Assessment Document assessed on a pass/fail basis by the Practice Assessor and Academic Assessor. The account of an episode of clinical care is assessed pass/fail by the Academic Assessor. Both components assess some of the same learning outcomes due to the practical basis of the module where the student will demonstrate in practice for component 1 and will critically analyse the evidence base for component 2.

## ADDITIONAL NOTES

In this clinical practice module students will undertake 40 hours per week in practice settings for 21 weeks (standard route) or 16 Weeks (alternative route). There are two Practice Learning Experience (PLE) blocks, each with an assessment opportunity and for students on the standard route, an opportunity to undertake an elective placement. To complete the module, student must have attended at least 70% of each allocated PLE to be assessed, achieve a pass grades in all PLEs and achieve all Stage 2 NMC proficiencies. This will be in a variety of practice placements. This module is underpinned by the UNICEF baby friendly Initiative.
